Basic Definition: Artwork includes any paint media; works that hang on a wall or displayed on an easel.

I understand and agree to the following:

- I understand that my art may be removed from the venue at any time at the sole discretion of the Grand Haven Main Street.
- I understand it is my responsibility to find my own venue; and I will work with that venue to develop space, display, lighting and traffic flow. A list of participating venues will be made available on the GH Artwalk website: www.ghartwalk.com
- I understand that I may have one piece submitted for one entry fee, or a body of work which may consist of several pieces that make up a larger collage within a single category.
- I understand it is my responsibility to coordinate drop-off and installation of my art on or before September 26, 2017.
- I understand it is my responsibility to work with the venue to coordinate all clean-up of space once the event is finished – at 5 p.m. on Sunday, October 8 – unless other arrangements are made in advance.
- I may sell submitted artwork, but it must remain on display through 5:00 p.m. on October 8, 2017. Any commissions and collection of sales tax are the responsibility of the artist to arrange with the venue.
- I grant the Grand Haven Main Street permission to take photographs of my entry/entries and grant Main Street irrevocable worldwide license to use photographs of my entry/entries on event materials and the GH Main Street/ArtWalk website and social media tools.
- I agree to indemnify and hold the Grand Haven Main Street harmless from a breach of, or any false statements made in, the artist rules/agreement, registration form and other representations, warranties et al., including attorney’s fees and litigation costs incurred by the Grand Haven Main Street relative to the same.
- All ArtWalk artist participants must be at least 18 years of age on or before August 1, 2017. *A separate ArtWalk Youth Competition is available for student artists.*

A **non-refundable \$25** artist registration fee **per entry** must accompany registration. *Entries will not be accepted without full payment.* Make checks payable to “**Grand Haven Main Street.**” **Entries must be received by 9/1/2017.**
